LIABILITY RELEASE & WAIVER AGREEMENT

In consideration of my junior sailor's participation in activities associated with the Hoover Sailing Club Junior Race Team, hosted by the Hoover Sailing Club of Westerville, Ohio, and others who have donated time and resources to the HSC JRT (like coaching, housing, boats and transport vehicles) this Agreement is made. The undersigned Participant's Parent and/or Legal Guardian, and their respective heirs, executors, administrators, personal representatives and next of kin (collectively as "Participant" and/or "Releasers"), hereby forever waive, release and discharge HSC JRT, its affiliates, and their respective members, managers, employees, volunteers, officers, directors, agents, representatives, successors and assigns, and all others who have donated time and resources to the HSC JRT (each a "Released Party") from any and all claims, demands, damages, judgments, executions, rights of action or causes of action, present or future, whether the same be known, anticipated or unanticipated, which a Releaser may have, or claim to have, against any Released Party resulting from death, personal injury, property damage or other loss Releaser may sustain as a result of participating in any sailing activity associated with the HSC JRT, or other related activities (including transportation and land-based activities).

THIS RELEASE IS INTENDED TO DISCHARGE EACH RELEASED PARTY FROM ANY AND ALL LIABILITY ARISING OUT OF OR CONNECTED IN ANY WAY WITH PARTICIPATION IN ALL ACTIVITIES ASSOCIATED WITH ANY OFF SITE COACHING, EVEN IF THAT LIABILITY ARISES OUT OF NEGLIGENCE OR CARELESSNESS ON THE PART OF ANY RELEASED PARTY.

Releasers hereby acknowledge that serious accidents may occur during sailing activities and that mortal or serious personal injuries and/or property damage or other loss may result from participation in sailing activities, including further injury or damage sustained as the result of the efforts of third parties who come to the aid of Participant. Releasers hereby agree to indemnify and hold harmless the Released Parties for claims, demands, damages, judgments, executions, rights of action or causes of action relating to any such injury or damage. Participant further acknowledges that the rules, regulations and guidelines of US Sailing (see www.ussailing.org) have been read and understood by and/or explained to the Participant sailor, including the fact that lifejackets must be worn at all times on or near any body of water, and agrees to abide by all rules and instructions from any person associated with the HSC JRT. Participant is financially responsible for any physical damaged caused by the Participant during the HSC JRT or any medical care rendered. Participant agrees that his or her failure to observe and obey such rules may result in revocation of the right to participate in any such activities without further recourse.
